# GSRA Day at the Capitol and Legislative Reception Wednesday, February 6, 2019

GSRA is busy preparing for one of our most important times of the year, the Legislative Session and our signature events related to it, GSRA Day at the Capitol and the GSRA/GPHSA Legislative Reception. Being a GSRA member and participating in GSRA events has never been more important. The gains we have made in making the legislature and administration aware of state retiree issues and concerns over the last three years have contributed to some very positive wins for state ERS retirees, including three one-time pension adjustments (the third adjustment split into two payments), increased funding for the pension fund, stable SHBP plans and premiums, and a DCH/SHBP Advisory Council to represent active and retired employee interests in the SHBP.

GSRA has never lost sight, however, of the desire of all ERS retirees to get back to receiving actual COLA adjustments annually to ensure that our purchasing power begins to be maintained again. With a new administration and new legislators taking office, we still have work to do regarding our ongoing efforts to educate our elected officials and advocate for our members.

The GSRA Day events are expressly designed to not only give our members opportunities to visit with their legislators and convey their concerns and issues, but also to thank them for their efforts on state retirees' behalf. In the morning, we'll distribute information to every legislative office on Capitol Hill. During the afternoon, we'll attend any appropriate legislative committee meeting(s). Then, that evening, we'll convene with our sister organization,

Georgia Professional Human Services Association, to provide a thank-you reception for legislators and their staffs. This Action Watch announcement includes all the details regarding both events. It's everything you need to know in order to plan your participation, and we hope you will sincerely plan to join us for these important events! Even if you cannot attend in person, please plan to support our efforts by watching for the Action Alert early in January which will allow you to extend a personal invitation to the reception to your legislators.

**Location:** Floyd Building/20<sup>th</sup> Floor/Empire Room

**Details:** Meet at the Empire Room between 4:30 and 5:00 PM in order to be ready to meet and greet legislators as they arrive. Please remember to make every effort to speak with legislators in attendance, particularly your own. Hors d'oeuvres and beverages will be available from 5:00 - 7:00 PM and both GSRA and GPHSA will recognize our annual "thank you" awards recipients at a short program beginning at 6:00 PM. (**Note: You will receive an Action Alert in January about inviting your legislators to the reception.**)

**Registration:** Registration fee is \$37.00. Members must be registered by January 31st and no registration will be done on site. #### Parking, Lodging and Marta Information

**Parking:** Several commercial lots are located on or around Capitol Hill, including the Underground Atlanta lot. For the Legislative Reception, the Pete Hackney lot at 162 Jesse Hill Jr. Dr. SE is the best location, however be aware that construction has affected the number of spaces available there. Parking at Pete Hackney is \$10.00 all day 6:00 am-9:00 pm. Across the street from the Capitol beside Liberty Plaza is the #1 daily lot which is \$10.00 flat rate open 24/7. The Steve Polk lot is pay by hour, so the rate varies based on time. The Butler parking deck will not be available to us this year.

**Lodging:** GPHSA has reserved a limited block of rooms at the Courtyard by Marriott Atlanta Decatur, Downtown/Emory at 130 Clairemont Avenue, Decatur, 30030, an easy Marta ride from Capitol Hill. The room rate is \$152.00 + tax per night (single/double). **The deadline for reservations at the \$152.00 rate is January 23, 2019.** The parking fee for the hotel overnight stay is \$8.00. You may choose to park at the hotel for the Legislative Day Event and/or the Legislative Reception at this rate and ride Marta to the Floyd Building. Marta: Leave the front entrance of the hotel. Walk out onto the sidewalk of Clairemont Ave. With the hotel to your back look up Clairemont to your right. You will see the old DeKalb Courthouse ½ block up the street. The entrance to the Decatur Marta Station is on the far side of the old Courthouse property on your right. Enter the station and go to the Westbound entrance. The train runs every 10 minutes from 3PM to 7PM, 12-15 minutes from 7-8:30PM, and every 20 minutes after that. The Marta Fare is \$2.50 each way. Exit at the Georgia State Station. To get back to Decatur go back to the Ga State Station and take the East Line to Decatur.
