# **GSRA** Day at the Capitol and Legislative Reception January 31, 2012

GSRA is providing you an opportunity to express your opinion on issues to legislators face-to-face on Tuesday, January 31, 2012. In being proactive concerning legislative matters, GSRA has planned two events: the GSRA Day at the Capitol that will begin at 11:00 a.m. and the Legislative Reception that will begin at 5:00 p.m. in the *Empire Room of the Floyd Building* 

The success of these two events will depend on the number of participating GSRA members and the quality of the messages they will deliver. Together, we need to express the retirees' viewpoints on issues important to retirees and to mitigate any legislators' preconceptions based on negatively biased reports about both active and retired employees.

# How You Can Help

Attend and be a part of the effort to impact the decisions made on behalf of the members of the State's pension plans and health insurance.

#### GSRA Day at the Capitol – 11:00 a.m.

The first event, GSRA Day at the Capitol, will begin around 11:00 a.m. GSRA members will meet at 11:00 a.m. at the Capitol Rotunda, second floor. We will give you an identification badge, provide a short orientation and distribute materials to you.

At minimum, we ask you to walk the halls of the Capitol, smiling and wearing a GSRA badge. If you are comfortable visiting with your Senator and/or Representative, let him or her know the issues that are important to you. We will provide you with "talking points" to guide your discussions with legislators, and with brochures/fliers and promotional items (GSRA tote bag, pens and water bottles) to leave with the legislators, in addition to inviting the legislators to the reception later in the day.

Our goal is to visit all of the legislators, so GSRA members who volunteer will be asked to visit legislators' offices other than their own.

If there is a committee meeting scheduled on that day, you may want to sit in to listen. Last year, the Senate Retirement Committee met during the

afternoon, and a number of GSRA members, to their delight, were able to attend.

#### GSRA Legislative Reception-5:00 to 7:00 p.m.

The Legislative Reception hosted with GCWA (Georgia County Welfare Association), will be held in the Empire Room, Floyd Building.

The Reception is being hosted to honor our elected senators and representatives and will provide you another opportunity to meet your legislators and discuss matters of concern to retirees and employees. We will have a short program at 6:00 p.m. and present an award to a legislator who best supported retirees during the past year.

A registration fee of \$35 is required for this event. Available during the reception will be finger foods, beer and wine. For GSRA members registering by the deadline of January 24, 2012, their membership with GSRA will be extended for 12 months. Attendees are asked to arrive at 4:30 p.m. for a short orientation. Registration information is included with this Action Watch. Parking information will be sent within the next two weeks.

Regardless of whether you personally attend either event in Atlanta, it is very important that you contact your legislators and invite them to attend the reception. GSRA has made the invitation process very easy for those members who have provided us with an email address.

On December 9, 2011, you should have received the first "message" from our new software about the GSRA Day at the Capitol. You were asked to "click" on the box "act now" and invite, via email, your state senator and representative to attend the reception. If you invited your representatives, we thank you. A

second email will be sent to you around January 9<sup>th</sup> to remind you to invite your senator and representative.

Procedurally, using the new software is very easy. In fact, we will be using this process throughout the General Assembly Session to notify you of actions that you may want to take regarding issues. When you receive an email message,

 Click on "act now" and if the screen is presented to you to verify your email address, click "yes."

- You will then be presented a screen that suggests a message to your state senator and representative.
- If you like the message, you can simply click on the "send message" box and it will be sent to your representatives. However, you are encouraged to modify the message for your personal touch. You may do this by typing in the changes that you would like to make. You would then send the message by clicking on the "send message" box.

## **Registration Information**

This is an important day for all GSRA members! Not only is it an opportunity for interaction with your legislators, it is an opportunity to augment GSRA as a valuable resource for legislators concerning retirement issues, i.e., the appropriate use of pension funds and funding for retirement and health insurance.

You can register for either or both events as described below in each section. Your local chapter may also assist you in the registration process.

#### GSRA Day at the Capitol - 11:00 AM

Type the name of the attendees and the city and county of residence in the subject line or the body of the e-mail or note – we need this information to make GSRA badges. There is no charge for this event.

#### GSRA Legislative Reception - 5:00 pm

- Click on the link provided for the ACTION WATCH in the "What's New" box on the GSRA home page.

- 3. The link will allow you to complete the form and charge the \$35 to your credit card.
- 4. If you want to pay by check, print and complete the attached form, attach a check for \$35 made payable to Georgia State Retirees Association, Inc. Send the check and registration form to: GSRA, PO Box 108, Bethlehem. GA 30620

All registrations must be received by January 24, 2012, including the mailed forms and checks.

**CAUTION:** There will be no registration at the reception. <u>If you do not pre-register, you will not be allowed to attend. So get your registration in early.</u>

Your participation is absolutely vital! As a reward for participation, each member registering for the Reception by January 24, 2012 will have his/her GSRA membership extended for 12 months. Each new member will receive a free initial membership.

You may receive additional information through your Local GSRA Chapter as some Chapters may plan additional activities.

We need to express retirees' viewpoints on issues important to us and to hopefully mitigate any negative preconceptions based on biased reports
