Who may join GSRA?

- Any retired or active state employee or educator* eligible for coverage in a state-sponsored health or retirement plan
- Spouses, immediate family members and beneficiaries of eligible persons
- Former state employees / educators who vested in a retirement plan, but who left state employment before retirement
- Retirees living outside of Georgia

*Includes local school system personnel and employees of the Board of Regents

What does it cost?

Annual dues are \$24 per 12-month period, starting with the month of registration. Automatic monthly pension deduction of \$2 per month is available. Lifetime memberships are offered at \$360.
