# Amended FY 2024 Budget Passed, No Bills of Consequence Good or Bad Passed

The FY 2024 Amended Budget has been passed and sent to Governor Kemp for signature. It retains the governor's recommended \$500 million to pay off unfunded liabilities and increase the funding percentage by about 2.5% to around 74%. We continue to hear that the governor and leadership intend to add another \$500 million in each of the next two years to hopefully raise the funding percentage to 80%, so long as that money is "available."

As reported last month, these huge amounts are good in the long run. They will ensure the continued viability of the fund's ability to pay retirees their **current** benefits. But these \$500 million investments **WILL NOT HELP** retirees in the short run in that they will not fund COLAs. Furthermore, as noticed by GSRA earlier this month, the \$500 million is being appropriated in such a way that it is not likely to draw down matching federal dollars the same as is being done by the governor's funding for average 1% COLAs and by the ADEC (actuarially determined employer's contribution. This will result in Georgia **MISSING OUT ON** roughly an additional **\$183 MILLION in FEDERAL FUNDS**. This would fund upwards of one-time additional **1.3% COLA** depending on the results of the ERS board's formula for granting COLAs. While several key legislators expressed interest in GSRA's recommendation, they were unable to make it happen for various reasons.

GSRA only found out about the method of appropriation last month and we were unable to change enough minds in such a short time frame. We will begin our advocacy for next year as soon as possible.

The governor's recommended \$26.75 million for one-time benefit adjustments this year has also been retained.

As of day 26, no further action has been taken on HB 824 (create new law enforcement retirement system) which would cost just under \$200 million total, nor HB 746 (redefine "earnable compensation") which would cost the retirement system just under \$150 million total.

No new bills impacting us have been introduced since last month's reports. "Crossover Day" will coincide with "Leap Day," Thursday February 29, 2024.

### It's an Election Year: What You Need to Know

Georgia voters will head to the polls at least three times in 2024, possibly five times, if runoffs are needed.

Voters first head to the polls for the **Presidential Preference Primary**, which will be March 12<sup>th</sup>, to select presidential candidates to be placed on the November ballot. You must declare a party preference to vote in the Presidential Primary. Advance voting began on February 19<sup>th</sup> and runs through March 8<sup>th</sup>. Absentee ballots may be requested through March 1<sup>st</sup>.

Voters will head to the polls again on May 21<sup>st</sup> for the **General Primary / Nonpartisan Election**. This election includes local positions, state and federal representatives, and party questions. A party preference must be declared in the General Primary. If a non-partisan ballot is requested, only the local Judicial Circuit Judges will appear on the ballot. Qualifying for local positions, regardless of party, is March 4<sup>th</sup> through March 8<sup>th</sup>. Advance voting for the General Primary is April 29<sup>th</sup> to May 17<sup>th</sup>.

The **General Election** will be Tuesday, November 5<sup>th</sup>. Advance voting for the General Election will be October 15<sup>th</sup> through November 1<sup>st</sup>.


