# 2024 Annual Meeting Macon, Georgia October 7<sup>th</sup> & 8<sup>th</sup> "Teamwork Makes the Dream Work"

GSRA will hold its 2024 Annual Meeting on October 7-8, 2024, at the Robert F. Hatcher Sr. Conference Center on the Middle Georgia State University campus in Macon. We will begin on Monday, October 7, at 12:15 PM in the Banquet Hall. Lunch will be on your own on Monday. You're welcome to bring your lunch to the meeting on Monday; lunch on Tuesday is included with your registration.

We have an exciting meeting agenda. On 12:30 Monday, President Robert Riddle will moderate a panel discussion featuring **Rep. Matt Hatchett, Chair,** House Appropriations Committee; **Rep. #### Things to Know

Middle Georgia State University is off I-475 at Exit 3, Eisenhower Pkwy/US 80. Directions: From I-475 Exit 3, head west on Eisenhower Pkwy/US 80. MGSU will be on the right. Take the second entrance into campus and turn left on University Pkwy. If you are coming from the west side of Macon (from Columbus, for example) on US 80, the campus will be on your left, and you'll take the first entrance into the campus. Turn left on University Pkwy.

Follow the signs for the Robert F. Hatcher Sr. Conference Center. The Conference Center is inside the Charles H. Jones Building. No sign outside the building indicates that the Conference Center is inside. To the right of the building is a handicap ramp. Once you enter the Charles H. Jones Building, you will see the Robert F. Hatcher Conference Center. Your ever-faithful Annual Meeting Committee had a hard time finding the Conference Center the first time we tried; we were glad we kept looking once we found it.

Due to upcoming changes in our health insurance and the October Annual Meeting, we asked B.J. Bennett and Kip Mann to update members. After lunch provided by the Chapter, President David Taylor introduced Kip Mann, who gave an overview of the SHBP changes and what members must do to select providers this year, including a review of costs, needs, and services. He also encouraged members to attend the Annual Meeting on October 7th and 8th, where vendors and SHBP representatives will be present.

B. J. Bennett then presented detailed explanations of the changes and gave members a two-page handout summarizing the new plans and premiums. She explained the selection process, with Anthem and United Healthcare being the finalists. One of the most salient points is that members must choose a provider this year, a significant change from prior years. If a selection is not made, the member's plan will revert to the lowest-cost plan, which is Anthem. She also reviewed the services provided in each plan and premium levels.
