Senate Retirement Bill Passes Key Hurdle

On June 4th, the Senate Retirement Committee met to discuss and vote on whether to submit certain proposed bills for an actuary study. This approval is a key step for any legislation that deals with the state's retirement systems and has fiscal impact (i.e., might cost the retirement system money).

One of the bills under consideration by the Senate Retirement Committee was Senator Nan Orrock's bill (Senate Bill 167) that would mandate 3% annual cost of living adjustments (referred to as "COLAs") for all qualified retired state employees and their beneficiaries. SB167 also effectively removes from statute the prohibition against COLAs for those members retiring under the GSEPS retirement plan.

A "No" vote would have doomed the bill to failure. A "yes" vote would allow the bill to be considered in the upcoming 2022 legislative session.

Senator Orrock, GSRA President Jim Sommerville, and Department of Labor retiree Jim DeLoach spoke before the Senate Retirement Committee in support of the bill. Notably, no one spoke before the committee in opposition of the bill. It should be noted that Jim Potvin, Executive Director of the Employees' Retirement System of Georgia (ERS), was in attendance. In addition, when Senate Retirement Committee Chairman Senator Randy Robertson brought the proposed bill for discussion, none of the

members of the committee spoke against the bill or raised any questions or issues concerning the bill.

To our great relief, the Senate Retirement Committee voted unanimously to forward the bill to the actuaries for an actuarial study.

As Chairman Robertson told GSRA representatives after the meeting, this action by the committee is one of if not the most substantial actions taken by the legislature to benefit ERS retirees.

While this is a key step for the proposed bill to achieve, the bill will still need to be approved by the Senate Retirement Committee and passed by both chambers of the legislature, and then not be vetoed by the Governor, before it can become law.

A lot of hard work still remains to be done in order to see SB167 signed into law. But the bipartisan vote by the Senate Retirement Committee to forward SB167 for actuarial review is a starting point towards getting COLAs restored for retired state employees and towards improving the GSEPS retirement plan for current active state employees.

ERS retirees owe a great deal of thanks and gratitude to Senator Nan Orrock, Senator Randy Robertson, and the other members of the Senate Retirement Committee for the historic steps that they have taken in 2021.

ERS Board Meeting in June

On June 17th, the ERS Board of Trustees held their last meeting of the current fiscal year (the fiscal year began on July 1, 2020 and ends on June 30, 2021). Although no major decisions are normally made by the ERS Board at their June meeting, there were a couple of notable items that occurred at that meeting.

Board Chair Eli Niepoky, whose current term ends on June 30, 2021, was elected to another four year term on the Board. In addition, Ms. Niepoky was elected to another one year term as Chair of the ERS Board of Trustees.

Commissioner of the Department of Administrative Services and current Board member Alex Atwood was elected to serve a one year term as Vice-Chair of the ERS Board.

The most important items of interest to retired state employees to come out of this meeting were Jim Potvin's statements that the return on investment for the ERS Fund as of Jun 16, 2021 is in excess of 28% and that the Fund has grown close to \$3 billion in the current fiscal year (an increase of almost 22%).

So, I come before you to ask for your forgiveness for doubting the level of support you would provide for our strategic planning process. After almost three years as President, I should have known better than to doubt your level of support for GSRA.

As for the strategic planning process itself, things are moving along right on schedule. The folks at UGA are currently compiling and analyzing the data from the questionnaire and are conducting a series of stakeholder interviews. Thank you to those GSRA members and affiliates who volunteered to be interviewed by UGA. Also, the Strategic Planning Committee has completed its work on developing new Mission and Vision statements for GSRA. The Strategic Planning Committee will be meeting and working throughout the summer months to finalize a proposed strategic plan.
